minutes of the meeting:

- 1) Principal extended a warm welcome to all the members. Initiatives taken by the school such as 21st century skills, skill integration, achievements and best practices were highlighted. Following agenda points were discussed in

detail:

- 2) Compliances of previous EPTA meeting:
Principal has given compliances of EPTA II meeting and all the members were satisfied.
- 3) Online school - students & parents feedback:
summary of students' feedback Term I for online school was shared with the members along with compliance for low scoring area.
- 4) Achievements of the school:
school authority shared remarkable school achievements with the EPTA members. All members appreciated and congratulated to the school.
- 5) Upcoming events:
Details of upcoming events like NABET assessment, Annual day, Navritya Kaumudi etc were shared.
- 6) NABET assessment status and report:
School authority shared with the members NABET assessment domain wise score. Tentative date of readiness assessment were also shared with target.
- 7) Fees outstanding - An appeal to EPTA and Easy and fees EMI.
- 8) The management of school has informed to the EPTA members, that as a difficulty raised due to prevailing Covid-19 Pandemic in resumption and conducting of physical classes

in the school, though a fees increase of 15% over the fees applicable for the academic year 2019-20 was approved for the academic year 2020-21 & 2021-22, but the school management has not increased the approved fees increase of 15% for the academic session 2020-21 and has charged the same fees as ~~was~~ was charged in academic year 2019-20.

Considering the fact that the Covid-19 pandemic has had its damaging effect on the financial condition of several families and to enable the parents to ensure a smooth flow of education of their wards and regular payment of fees to the school, the management has considered the request of parents sympathetically and has granted a waiver of 10% in the fees for the academic year 2020-21.

Further to above, the management has allowed a waiver of 15% equal to approved increase in the fees for the academic year 2021-22 solely on humanitarian grounds.

Details of outstanding ^{fees} for the session 2019-20 till 2021-22 were shared by the Principal. An appeal was made to extend support in recovering the school outstanding fees.

School authority made the members aware about the benefits of Easy fees EMI scheme.

In the open session an appeal was made to all EPTA members to share their opinion regarding conduction of online classes. All the members appreciated the online classes.

and praised for the efforts taken by the school.

9) Fees approval for the academic session 2022-23 and 2023-24:

School management has proposed the increase in school fees by 15% over the fees applicable for the academic year 2021-22.

The above proposal has been considered by the Executive Parents Teachers Association (herein after referred to as "EPTA"), keeping in mind the various factors mentioned in section 9 of the Maharashtra Educational Institutions (Regulation of Fees) Act, 2011 (hereinafter referred to as "said act") and on finding the aforesaid proposal to be reasonable, the EPTA has approved the increased school fees by 15% over the fees applicable for the academic year 2021-22. This approved fee will be applicable for the academic sessions 2022-23 & 2023-24.

Though the above increase of fees has been approved by the EPTA, in case of any difficulty in resumption and conducting of physical classes in the school, the school management shall consider granting waiver of 5% in fees. The said waiver is being offered considering the experience, relating to utilization of various facilities, services, etc, during the previous period of Covid-19 pandemic.

The today's minutes of the meeting dated 16th December 2021 were read and approved by all the present EPTA members.
